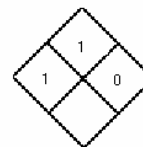

SECTION 3 - HAZARDOUS INGREDIENTS

The No Survivor insect trap contains no pesticide chemicals or hazardous ingredients. It kills insects by trapping them onto the sticky glue that coats the inside of the trap.

Petroleum wax, linear hydrocarbon [glue] No CAS No. Ca. 45% wt.

SECTION 4 - PROPERTIES

The trap components are made from waxed milk carton paper. This is an inert paper product. The inner side of the trap component is coated with the sticky material to prevent insect escape. The sticky glue comes packaged with a contact release paper covering the glue.

Toxicity: No toxicity known.

Odor: Mild hydrocarbon odor

Color: Translucent

Physical State and Appearance: Translucent gel on waxy paper.

Adverse Conditions: Dust makes glue ineffective.

EFFECTS OF OVEREXPOSURE (ROUTE)

Dermal: Avoid contact with skin. Contact with skin will require minimal to moderate force to remove. For contact with large areas, get medical assistance.

Ocular: Avoid contact with eyes. Get medical attention to assist with removal.

Inhalation: No toxic effects are known to be associated with inhalation of the odor from this material.

Ingestion: Ingestion is not expected to occur or cause adverse effects if ingested in small quantities. Seek medical attention if > 1 oz is ingested.

EMERGENCY AND FIRST AID PROCEDURES

Skin Contact: Use of vegetable or baby oil will assist in removal. Wash with soap and water after removal. Get medical attention if irritation develops.

Eye Contact: Get medical attention immediately.

Inhalation: If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Get medical attention if symptoms appear.

Ingestion: Do NOT induce vomiting unless directed to do so by medical personnel. Never give anything by mouth to an unconscious person. Loosen tight clothing such as a collar, tie, belt or waistband. Get medical attention if symptoms appear.
